Also included are programs that help people identify and secure paid employment opportunities that match their aptitude, qualifications, experience and interests.” (Reference - Michigan 2-1-1)

- Eligibility based on household number, income and countable cash assets
- Can use MIBridges online to apply for assistance, check your eligibility status and manage account at <https://www.mibridges.michigan.gov/access>
- Assistance also available via walk-in service; Mon-Fri 8am-5pm

***State Emergency Relief (SER)***

- Immediate help may be available if facing extreme hardship or emergencies
  - Utilities, Home Repairs, Relocation, Home Ownership Services, Burial
- Not intended for repeated or long-term use
- For energy related emergencies, the SER crisis season runs Nov 1<sup>st</sup>-May 31<sup>st</sup>

***Home Ownership Services***

- If at risk of losing your home, this service may be able to help with services such as:
  - Home mortgage or land contract payments, including principal, interest, legal fees and escrow for taxes and insurance
  - Property taxes and fees
  - Mobile home lot rent for owners or purchasers of mobile homes
  - Insurance coverage required by a mortgage or land contract
- Lifetime services maximum is \$2,000
- Cannot be client-caused

***Family Independence Program (FIP)***

- Provides temporary financial assistance to families with children
- Eligibility requirements:
  - Households must have children 0-18 or 18 who are in high school fulltime
  - Pregnant women and families whose children are in foster care but expected to return within 1 year

- Meet income limits
- Be under-employed, unemployed or about to become unemployed
- Be a MI resident

***Cash Assistance***

- Temporary cash assistance is available for eligible pregnant women & low-income families with minor children
- Applicants for will take part in a results-oriented work participation program (PATH)
  - Program features a 21-day assessment period during which barriers to employment are identified and caseworkers work to connect participants with resources to address barriers

- Referral required from a caseworker
- Walk-ins accepted; Hours vary, please call for details
- Picture ID required

- Some programs require specific eligibility or a referral, however, ANY job seeker can use Employment Services
- Generally, walk-ins accepted: Mon-Fri 8am-5pm

*Adult and Dislocated Worker Programs*

- Provides classroom training, on-the-job training, remedial education, job search assistance and supportive services for eligible individuals
- Some programs have eligibility and documentation requirements; call for details

*Youth Program*

- Programs that provide work-readiness training for youth age 14-24 from low-income households or are at risk of dropping out of school; and adults age 18 and older who are low-income and/or receiving public assistance and are unemployed
- Goal is to prepare youth for high school graduation, post-secondary education and, ultimately, a career

*Comprehensive Job Assistance Centers/Employee Assistance Programs*

- Provides services to all employers and all job seekers
- Possible activities include resume writing, interview coaching, work experience, career assessment and counseling, on the job training, job search, employment postings/listing, computer access with

internet connections, career fairs, bilingual support and reference materials/labor market information

- Some programs do have eligibility requirements. Referral from DHS is required for some programs, call for more details

*Job Seekers Programs*

- Provides computer or related technology classes, GED test instruction classes as well as other classes that will aid in employment, and literacy programs
- No eligibility requirements for service
- Call for current class schedule: Mon-Fri 8am-5pm

- A non-profit law firm that provides free civil legal assistance and advice to low and moderate income people in the eastern part of the state, including Flint, Saginaw, Midland, and Port Huron
- In addition to legal assistance, they offer help on Credit Repair, Bankruptcy, various Legal Empowerment & Advice Programs
- Legal advice related to:
  - Family law, consumer problems, housing issues, evictions, government benefits, bankruptcy, education, fair housing individual rights, wills, services for seniors
- Call to schedule an appointment: Mon-Fri 9am-5pm

*Housing Problems*

- Provides information and possible assistance regarding mortgage foreclosure and delinquency and landlord tenant disputes
- May accept cases for representation for issues within their priorities
- May also be able to provide counsel and advice, or do-it-yourself materials.
- Services are free for clients that meet income eligibility, clients may be responsible for court costs

*Bankruptcy Assistance*

- Provides assistance for people who are unable to pay their creditors and need to declare bankruptcy. Included may be help in evaluating a personal or business bankruptcy as an option, assistance in completing and filing bankruptcy forms and/or representation in bankruptcy hearings
