- Calls will be taken till they have met their quota

- Has a waiting list

Permanent Supportive Housing Program

- Provides permanent housing for singles and families with case management services
- Clients must spend 30 days in an Emergency Shelter before they can transfer to the program
- Must have income and documented disability

- Call to apply, 24hrs

- Funds may only be used to improve homes in Genesee County’s Community Development Block Grant participating communities, excluding the City of Flint
