Housing Problems

- Provides information and possible assistance regarding mortgage foreclosure and delinquency and landlord tenant disputes
- May accept cases for representation for issues within their priorities
- May also be able to provide counsel and advice, or do-it-yourself materials.
- Services are free for income eligible, clients may be responsible for court costs

Bankruptcy Assistance

 Provides assistance for people who are unable to pay their creditors and need to declare bankruptcy. Included may be help in evaluating a personal or business bankruptcy as an option, assistance in completing and filing bankruptcy forms and/or representation in bankruptcy hearings
